ANNOUNCEMENT PURSUANT TO RULE 704(17)(b) AND RULE 704(18)(b) OF THE LISTING MANUAL OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED

The Board of Directors of mDR Limited (the “**Company**” and together with its subsidiaries the “**Group**”) wishes to announce that pursuant to Rule 704(17)(b) of the Mainboard Rules of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Group has acquired quoted securities for a total value of approximately S\$11,020,197 for the period 12 December 2025 to 17 December 2025. This is equivalent to 7.4% of the latest audited net tangible assets of the Group.

Pursuant to Rule 704(18)(b) of the Mainboard Rules of the Listing Manual of the Singapore Exchange Securities Trading Limited, the Group has sold quoted securities of approximately S\$4,615,323 (based on historical cost) for the period 12 December 2025 to 17 December 2025. This is equivalent to 3.1% of the latest audited consolidated net tangible assets of the Group.
